Parents 'Feedback:


Majority Parents stated that overall the syllabus is satisfactory and given suggestions for more hands on and field practices and internship

Majority alumni were satisfied with the syllabus and suggested a parallel program for employability of passing out students.




3. CONCEPTUAL UNDERSTANDING OF THE COURSE








